#### A. REQUIREMENT OF GOODS:

Design, Print and Supplying of NFC Technology enabled Convocation Certificates along with software technology for verification and authentication including printing of student variable data.

#### B. **ELIGIBILITY CONDITIONS:**

The prospective Bidders should meet the following pre-qualification criteria. Both Technical and Financial Bids which are not compliant with said criteria will not be evaluated and rejected out rightly without assigning any reasons. Firms/Companies intending to participate shall fulfil the following eligibility criteria:

 Bidder must be Public or Private limited company as per Companies Act 1956 (Self attested copy of Certificate of Incorporation must be attached along with Technical Bids)

- Bidder must have completed atleast two financial year as on 31<sup>st</sup> March 2017 (a self-declaration must be attached along with the Technical Bid),
- 3. The bidder must have minimum Turnover of Rs. 50 lakhs Per annum for last two years (a Certificate from the Chartered accountant must be attached along with Technical Bids)
- 4. Bidder should not have been black listed by any State or Central Government Department in India. Company/Firm should submit a self-declaration in this regard. Any false declaration would lead to rejection of Bids. (Self-Attested declaration must be attached along with Technical Bid)
- 5. Bidder must have successfully executed at least one turnkey project including Design, Supply and Printing (Variable/Students Data) of NFC Microchip embedded Marks Cards or Certificates (as per the Technical Specification mentioned in the Appendix-I) with related Technology for Verification and Authentication to at least one State Owned University in India. (A copy of Work Order/ Agreement with the satisfactory completion certificate from the customer must be attached with the Technical Bids).
- 6. Bidder must have valid VAT & Service Tax Registration Certificate (Self attested copies of registration certificates must be enclosed with Technical Bid).
- 7. Bidder must have valid PAN number (Self attested copy of PAN certificate must be enclosed with Technical Bid).
- 8. Bidder shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by Government of Karnataka. (A self-declaration must be attached with the Technical Bid),
- 9. Above eligibility criteria are essential for technical qualification.

#### C. TERMS & CONDITIONS:

- 1. Bidders should provide their CIN number and TAN number.
- 2. Bidders have to submit their tender along with EMD amount mentioned in the notification, by DD drawn in favour of Finance officer, Karnataka Sanskrit

- University, payable at Bangalore.
- 3. Bidder who gains contract should do the necessary art work before printing of Convocation certificates and get it approved from University.
- 4. Bidders should quote their price inclusive of transportation charges and VAT to deliver the goods to the university.
- 5. Bidder should be capable of completing the variable data printing work within 15 days after the issuance of work order.
- 6. The entire work intended to be tendered is of confidential in nature. Hence absolute accuracy and confidentiality should be maintained by the successful Bidder. The successful Bidder must sign a Non-Disclosure Agreement (NDA) with KSU
- 7. Any failure to complete the work as per schedule prescribed will lead to the breach of agreement and his EMD amount will be forfeited as a penalty.
- 8. Upon evaluation of Commercial Bids and making comparative statement after taking into account all the relevant aspect of the Tender condition, KSU shall declare lowest quoted Bidder as L1 Bidder and next lowest quoted Bidder as L2 Bidder. KSU will notify L1 Bidder as successful Bidder. The successful Bidder will be intimated in writing by registered letter, that its Bid has been accepted. The successful Bidder will do the necessary work after receiving the order.
- 9. KSU will provide the students data in application formats. Bidder should himself create a data suitable to print on certificates based on students applications.
- 10. Bidders who bid for variable data printing should also maintain the data of serial number of the Convocation certificates issued to each student and maintain the data of serial number of the Convocation certificates issued to each college. Later the same should be provided it to the university.
- 11. Bidders should be ready to do any corrections and technical consultancy services at free of cost after distributing the Convocation certificates.
- 12. University reserves its right to reject the tenders without any intimation

- 13. Providing verification Technology solution (mobile based verification and web based verification)
- 14. Payment Term: No advance payment will be made to the successful Bidder. 100% payment will be made to the successful Bidder only after successful completion of printing and supply of Convocation Certificates as per the work order/purchase order. The payment is subject to TDS deduction if applicable. The payment will be made only for accepted quantities.
