- 3) Tenders must be accompanied by Earnest Money Deposit of the amount specified in the tender document, drawn in favor of KSU Bangalore,
- 4) Technical Bid and Price Bid should be submitted through sealed quotations super scribing the tender No. on the envelope to the Registrar on or before 28-01-2022, 05.30PM. If the office happens to be closed on the date of receipt of the tenders as specified, the tenders will be received on the next working day up to 1.00PM.

Evaluation of the Tenders

- a) KSU shall first evaluate the technical bids. The commercial bids of only those bidders who qualified in the technical bids will be opened. The Price bid should be inclusive of allTaxes.
- b) Decision of the KSU in the evaluation of the Technical bids shall be final.

INSTRUCTIONS TO TENDERERS

ELIGIBLE TENDERER:

Sealed Tenders are invited from reputed vendors for the Supply of Marks Cardsaddressed to The Registrar, Karnataka Samskrit University, Pampa Mahakavi Road, Chamrajpet, Bangalore-560018. All Tenders in the prescribed form at Annexure-I should be submitted before the time and date fixed for the receipt of tenders as set forth in the tender papers. Tenders received after the stipulated time and date shall be rejected. Bidder shall not be under declaration of ineligibility for corrupt & fraudulent practices issued by the Government of Karnataka.

QUALIFYING REQUIREMENTS:

This section covers the minimum requirements with respect to experience, capability and other particulars of the Bidder to be considered eligible for participation in the bid for the proposed work. The bidder shall become eligible to bid on satisfying the following

<u>"Eligibility Criteria"</u> and on production of the required documentary evidences along with the Tender.

Eligibility criteria of the bidder: The bidder must meet the following eligibility criteria and must furnish the proof of documents in Technical Bid thereof otherwise the bid will be rejected.

TECHNICAL ELIGIBILITY CRITERIA

- 1. The Bidder should be empanelled with KSU for Commercial activities.
- 2. The annual turn-over of the company should be more than 20 lakhs average in last 3 financial years i.e. for 2018-19, 2019-20 & 2020-21.
- 3. The bidder should not have been black listed in past/debarred from any State /Central Govt, PSU's. Nationalized Banks Etc. (Declaration should be attached)
- 4. The bidder should have executed similar works of Rs. 25 lakhs for Govt. bodies in the last financial year. Performance/Completion certificate as Proof of execution of orders shall been closed.
- 5. IT returns or Balance sheet for last three years i.e. (2018-19, 2019-20 & 2020-21) shall be enclosed.
- 6. Copies of PAN Card, ROC/Establishment of Company/firm, GST registration details shall be submitted.

EARNEST MONEY DEPOSIT

- Tenderer shall accompany with Price Bid of tender an Earnest Money Deposit[EMD]of Rs. 20,000/- (Rupees Twenty thousand Only)
- EMD should be in the form of Crossed Demand Draft (Scheduled Nationalized Indian Banks Only) in favor of Finance Officer, Karnataka Samskrit University, Bangalore.
- The Earnest Money shall be valid and remain deposited with the Purchaser for the period of 60 days from the date of successful execution of project.
- No interest will be payable by the purchaser on the Earnest money.

• The Registrar, KSU, Bangalore, or authorized officer will open the tender on the time & date mentioned in Tender Form in the presence of the tenderers or their authorized representatives at the address mentioned in Tender Form for. In the event of the specified date of tender opening being declared a holiday, the tenders will be opened at the same time on the next workingday.

FRAUDS AND CORRUPTION:

Bidders, Suppliers, Contractors and their subcontractors and Consultants under observe the highest standard of ethics during the procurement and execution of such contracts. In pursuance of thispolicy,

a. Defines, for the purposes of this provision, the terms set forth below as follows:

- (i) "Corrupt practice" is the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another party;
- (ii) "Fraudulent practice" is any act or omission, including a misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain a financial or other benefit or to avoid anobligation;
- (iii) "Collusive practice" is an arrangement between two or more parties designed to achieve an improper purpose, including influencing improperly the actions of another party;
- (iv) "Coercive practice" is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actins of aparty;
- (v) "Obstructive practice"is:
- (a) deliberately destroying, falsifying, altering or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a KSU investigation into allegations of a corrupt, fraudulent, coercive or collusive practice; and threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; and
- (b) Acts intended to materially impede the exercise of the KSU's inspection and audit rights provided for under sub-paragraph (e)below.
- (c) Will reject a proposal for award if it determines that the Bidder recommended for award has, directly or through an agent, engaged in corrupt, fraudulent, collusive or coercive or obstructive practices in competing for the contract inquestion;
- (d) Will cancel the contract if it determines at any time that incorrupt, fraudulent collusive, coercive,

or obstructive practices during the execution of that contract KSU will take timely and appropriate action satisfactory to address such practices when theyoccur.

(e) Will sanction a firm or individual, including declaring them ineligible, either indefinitely or for a stated period of time, to be awarded a contract if it at any time determines that the firm has, directly or through an agent, engaged, in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for, or in executing, contract; and

AWARD OF CONTRACT

- The tender accepting authority has the right to accept any tender and to reject any or all tenders without assigning anyreason.
- Notwithstanding anything that is said herein, the tender accepting authority reserves the right to accept or reject any tender, and to cancel the tendering process and reject all tenders, at any time prior to the award of tender, without thereby incurring any liability to the affected tenderer or tenderers of the grounds for the authorized tender accepting committee action.

NOTIFICATION OF AWARD:

- On Opening the tender, the Registrar, Karnataka Samskrit University or authorized officer
 will read out the details as per the checklist of each tendered. No other details will be readout
 ordisclosed.
- Upon furnishing by the successful tenderer or tenderers the performance security deposit and upon signing the agreement the Directorate will promptly notify the other tenderers that their tenders have been unsuccessful and will arrange to return their EMDs.

REVIEW OF CONTRACTS BY KSU

- Bidders, suppliers, and contractors, under these contracts, observe the highest standard of
 ethics during the procurement and execution of contracts. In pursuance to the policy, KSU
 will have the right to require that a provision be included in bidding documents and in
 contracts, requiring bidders, suppliers, and contractors to permit to inspect their accounts and
 records and other documents relating to the submission and contract performance and to have
 them audited by auditors appointed by KSU.
- Contracts which are (I) not subject to prior review by the KSU, and (ii) awarded following these guidelines will be post reviewed by the KSU.

GENERAL
