According to the Government of India Letter No. BC 12025/2/76-SCT-I, Ministry of Home affairs, in order to be competent to issue such certificates, therefore, the authority mentioned in the Government of India [Department of Personnel and Administrative Reforms] Letter No. 13-2-7-EST-[SCT] dated the 5th August 1975, should be the one concerned with the locality in which the person applying for the certificate had his place or permanent abode at the time of the Notification of the relevent presidential Order.
