Subject No.	Subjects, Notes & Resolution
Subject No. 01	Regulations on CBCS to be implemented in our University. A committee had been constituted to draft the regulations of "Choice Based Credit System" in University campus. CBCS draft regulations has been submitted for approval.
Decision	Academic council approved the CBCS regulations.
Subject No. 02	Syllabus submitted by all the departments as per CBCS regulations. University has to implement the CBCS regulations with effect from the academic year 2020-21 to get included in the UGC clause 12B and get the ranking from NAAC. Hence, as a first step University has asked all the departments to revise the syllabus

	as per the CBCS regulations. So, permission is needed to implement the CBCS University campus and approval need for the revised syllabus submitted by every department.
Decision	Academic council approved the syllabus framed by all the departments in accordance with CBCS regulations with a condition that the necessary change should be made regarding credits and elective subjects.
Subject No. 03	Regulations governing Under Graduate, Post Graduate and other Part-Time Programs of our University. Even after ten years University doesn't have any regulations governing programmes run by university. A committee had been set up to frame the regulations governing all the programmes of the University. Draft regulations submitted for approval.
Decision	Academic council approved the regulations governing UG, PG & other part time programs.
Subject No. 04	Vedanta Yoga Sub Committee proceedings A committee was set up to look into the matters of Vedanta Yoga program. The committee proceedings have been submitted for approval.
Decision	Academic council approved the proceedings of a sub committee on starting Vedanta Yoga program. The program may be started after following the suggestions made by the sub - committee. Prof. K M Mahadevaiah suggested to start the programs in different Vedanta studies. Academic council accepted the suggestion and will look into this in near future.
Subject No. 05	Minutes of Evening College Committee A committee had been set up to look into the possibilities of establishing evening college in the campus of University. Committee has favourably resolved to establish evening college. It has also noted that security of students etc. should be kept in mind. Accordingly evening college has been established. Submitted for ratification.

Subject No. 06	Introducing a course on Indian Culture under generic elective courses for PG program and as an Add-on course for UG program. Subject No. 07	Making an MOU with Aksharam to organize Sambhashana Shibira at the beginning of every Academic Year as a part of skill ability development program. Karnataka Sanskrit University aims to organize a Sambhashana Shibira at the beginning of every Academic Year as part of skill ability development program in collaboration with Aksharam, Bengaluru. Therefore, the matter has been placed for approval to make MoU with Aksharam to organize a Sambhashana Shibira program.
Decision	Academic council approved to make an MOU with Aksharam to organize Sambhashana Shibira as a part of Skill ability program.

Subject No. 08	<p>Making an MOU with PPSM to organize Sarala Kathina Samskrit Program as a Bridge course at the beginning of every Academic Year.</p> <p>Karnataka Sanskrit University aims to launch a bridge-course 'Sarala-Kathina Sanskrit' program at the beginning of each Academic Year in collaboration with Poornaprajna Samshodhana Mandira, Bengaluru. Therefore, the matter has been placed for approval to make MoU with Poornaprajna Samshodhana Mandira to conduct a 'Sarala-Kathina Sanskrit' program Bridge Course.</p>
Decision	<p>Academic council approved to make an MOU with PPSM to organize Bridge course at the beginning of every academic year.</p>
Subject No. 09	<p>Request for change in post name by Prof. Veeranarayana N.K. Pandurangi.</p> <p>Prof. Veeranarayana N.K. Pandurangi has requested that his designation to be changed as Professor of Indian Philosophy Religion and History. Because he is active in these fields. Submitted for approval.</p>
Decision	<p>Hon'ble VC suggested to have the designation as Professor in Vedanta alias in Indian Philosophy and also suggested to discuss this issue in next syndicate meeting. Academic council agreed to take up the issue for discussion in next syndicate meeting.</p>
Subject No. 10	<p>Letter from Principal, SMSP Samskrit College, Udupi to provide Computer Science as optional subject in BA.</p> <p>Principal, SMSP Samskrit College, Udupi has requested to introduce Computer Science as optional subject at BA level for students of SMSP college. College has made the arrangements of computer lab that is necessary for this course. This matter is submitted for approval.</p>
Decision	<p>Academic council agreed to permit SMSP college to offer the computer science course as an optional from the academic year 2021-22</p>
Subject No. 11	<p>Proposal to permit students from non-traditional background to submit their Ph.D. thesis in English language.</p> <p>Prof. V. Girish Chandra, Dean, Language Faculty has given a request to permit students who come from non-traditional background (with a degree of MA in General Sanskrit in General Universities) to submit their thesis in English language. This helps University to increase the enrollment ratio in research programmes. The request letter is submitted for discussion and approval.</p>
Decision	<p>Hon'ble VC sir suggested not to permit in general, but certain applications may be considered on case to case basis with the approval of Dean's council. Academic council agreed the suggestion of Hon'ble VC.</p>
Subject No. 12	<p>Vedas are the first book of human kind dating back to nearly 5000BCE. These works contains the invaluable data of history, life, society, archaeology, astronomy, economy and culture of ancient India. However the archaic Samskrit language of Vedas makes it difficult to understand the vedic works clearly. There are many Vedabhashyas aiming to explain meaning of Vedas from adhiyajna perspective. Western scholars too have tried theirbest to decipher Vedic codes without much success, best summed up by Maxmuller as follows "Large number of Vedic hymns are childish in the extreme; tedious, low, commonplace." Thus there is a great need to understand the Vedic works in a comprehensive manner without any prejudice for adhiyajna or adhidaiva or adhyatma models taking all these views into consideration. Hence it is proposed to initiate a process of writing new Vedabhashya with modern view point and Indian tradition.</p>


