General Instructions to the Students

1. The University will not issue any notification pertaining to the Ph.D Annual fees and Library fees, annually the Ph.D scholars shall pay the annual fees, tuition fees according to the provisional registration order issued by the university.
2. It is the sole responsibility of the Ph.D scholar to pay the annual fees every year.
3. If the scholar fails to pay the annual fees of the respective years, then a fine of 10% shall be revied.
4. The University shall increase annual fees, tuition fees, Library fees and any other fees related to Ph.D by 10% annually.
5. The candidate who belongs to SC, ST, Cat-I. Category shall be provided 50% concession in fees as per the Government of Karnataka rules for SC, ST, Category students. The candidates whose family income doesn't exceed 2.50 lakhs annually shall be eligible for this concession.
6. Those candidates eligible for the concession shall provide the Income and Caste Certificate compulsorily. If not submitted they shall have to pay the Normal fees.
