01	Subject & Note	Approval of Statute Governing the Affiliation of Colleges/ Institutions under the jurisdiction of Karnataka Samskrit University 2019. Government has directed to approve the draft of common affiliation statute regarding affiliation of the colleges. in its letter no ED 240 UNE 2019, dated 19.12.2019. University has already placed the drafted statute before the 28 th

		meeting of Academic council and modified for necessary sections and sent the same to the government for approval. As observed by the government, section 3.1.1 is against the government/UGC directions. This section has to be changed as “undisputed ownership and possession of land free from any or all encombrances measuring not less than 0.5 acres if it is located in mega and metro cities, 1 acre if it is located in corporation limits, and 2 acres if it is located in other cities and taluka centres and 5 acres in other areas or by as determined by the Government of Karnataka from time to time.” Hence, the subject is placed before the Academic Council for approval of statute with necessary changes.

02	Subject & Note	Approval of statute governing the Samskrit Evening College. Karnataka Samskrit University has started Evening College at Chamarajpet campus as per the decision of Syndicate’s 56 th meeting dated 19.01.2021 and drafted a statute for the same. Hence the subject and draft statute placed before the Academic Council for approval.
