

Regulations governing Certificate and Diploma and other courses for jyotishya framed under Chapter II, section 5, sub-section 1 & 2 of Karnataka Samskrit University Act, 2009.

Preamble:

A number of Astrological Educational Institutions in Karnataka State are functioning to promote and provide vedic astrology to the public irrespective of caste, creed and religion. They have been conducting Jyotishya Courses from more than three decades. There are Three year course named as Jyotishya Pravesha, (1st year), Jyotishya Praveena (2nd Year) and Jyotishya Vibhooshana (3rd year). There are over 5000 students studying in these courses. The managements of all these institutions approached the KSU for recognizing the course under the framework of the University. The courses offered by these institutions are different from one another. There is no elaborate, detailed and uniform study of Astrological subjects. In order to bring uniformity and maintaining the standard Karnataka Sanskrit University has taken up extensive measures with the following objectives.

OBJECTIVES:

1. To promote the knowledge of Astrology and allied subjects in India & abroad by imparting standardized education in these areas.
2. To conduct scientific research on Astrology and allied subjects..
3. To standardize Astrological predictions and to promote scientific Astrologers and palmists.
4. To bring standards in the syllabus of on Spirituality, occultism, Yoga, Vastu, Palmstry, Vedas, Upanishads for the development of Vedic sciences to strengthen ethical and moral values of our society.
5. To apply this knowledge for Management, Medicine, Economics, Mundane matters etc in as acceptable manner.
6. To promote ancient knowledge of Astrology and Sanskrit in the country through Karnataka Sanskrit University.
7. To create new job opportunities in these fields.

With these objectives, these Regulations are framed for offering courses in Jyotishya and allied subjects.

Regulations governing Certificate and Diploma and other courses for Jyotishya framed under Chapter II, section 5, sub-section 1 & 2 of Karnataka Samskrit University Act, 2009.

1. TITLE

These Regulations shall be called as "Karnataka Samskrit University **Regulations governing Certificate and Diploma and other courses for Jyotishya** -2012 under Karnataka Samskrit University ACT 2009"

2. COMMENCEMENT

These Regulations shall come in to the force from the date of approval by the Chancellor.

3. DEFINITIONS

- 3.1 University means, "Karnataka Samskrit University" as specified under section 3 of the KSU Act – 2009.
- 3.2 Study Centre means "Study Centre declared by the Directorate of NFE of KSU".
- 3.3 Non Formal Education means "Directorate of Distance Education, Out Reach and Online Education of Karnataka Samskrit University" as specified above.

4. APPLICATION

These Regulations shall apply to:

- 4.1 All the courses in Jyotishya conducted under the Directorate of Non Formal Education of Karnataka Samskrit University.
- 4.2 All the schemes of examinations in Jyotishya offered by the Directorate of Non Formal Education: and
- 4.3 All such other schemes/courses as may be notified by the Directorate of Non Formal Education.

5. COURSE NAME


- 5.1 Certificate Course in Jyotishya (Astrology)
- 5.2 Diploma Course in Jyotishya (Astrology)
- 5.3 U.G. and P.G. courses in Jyotishya (Astrology)

6. ELIGIBILITY FOR THE COURSE

- 6.1 10+2 and above for seeking admission to certificate in Astrology course.

- 6.2 Those who have passed certificate in Astrology are eligible to take admission to Diploma in Astrology.
- 6.3 Eligibility for U.G. and P.G. courses as per the rules of the University.

7. COURSE FEE

- 7.1 Certificate Course in Astrology Rs. 1500/-
- 7.2 Diploma Course in Astrology Rs. 2000/-
- 7.3 As per the norms of the University.

Note: University may increase the fees from time to time with the approval of the Syndicate.

- 8.1 Kannada
- 8.2 English
- 8.3 Samskrit

9. DURATION


- 9.1 Certificate course in Astrology - (minimum six months and maximum 2 years)
- 9.2 Diploma course in Astrology (minimum one year and maximum 2 years)
- 9.3 U.G. and P.G. courses (As per the rules of the University)


10. RULES & REGULATIONS

- 10.1 The academic year starts in the month of May-June and ends in February-March. Classes are held between 3.00 to 6.00 PM every Saturdays / Sundays. The final examination is generally held during June/December. The instructions for the courses are given through the recognized study centres of the university.
- 10.2 On successful completion of the certificate & Diploma courses respectively students getting a minimum of 60% and above are placed in the "FIRST CLASS" and those getting minimum of 50% in "SECOND CLASS". To pass the course, students should secure a minimum of 35%.

NOTE:

1. Admission is restricted to a specific number of seats in each class as well as in each institute.
2. False declaration of age/qualification, etc., by the applicant will disqualify him/her for admission to the certificate/diploma courses.
3. The final decision to select or reject a candidate for admission rests with the Board of the Karnataka State Samskrit University.
4. No correspondence will be entertained regarding selection/rejection by the University.

5. No fee concession will be allowed to anyone & also once fee paid by the Student will not be **refunded at any cost.**
6. All students will be issued Identity Cards & the same is required to be preserved carefully till the end of the course. The same will be checked by the concerned authorities at the time of inspection.
7. The classes will be conducted on Saturday/Sundays afternoons at the premises, intimated by the Karnataka Sanskrit University or Astrological Institutions.
8. The Karnataka Samskrit University conducts special lecturers by eminent scholars wherever necessary during the course.
9. Student registration shall confer to the course to which they have been admitted & will not confer any other rights.
10. All the students who ever joins for the course has to maintain the classroom discipline and diary.
11. Those who are admitted to the course are required to bring one or two ancient astrology source books as and when required..
12. No holidays will be declared on Saturday/Sundays until there is some unavoidable circumstances.
13. If any student passing any other similar courses in any institutions wanted to join this institute, he/she will be examined before admitting to that course by the authorities.
14. If the Karnataka Samskrit University finds any negligence, misbehavior etc. by any discipline, he/she will be removed from the university.

11. ELIGIBILITY CRITERIA FOR APPOINTMENT AS ACADEMIC COUNSELLOR FOR CERTIFICATE/DIPLOMA IN ASTROLOGY FOR KARNATAKA SANSKRIT UNIVERSITY (KSU)

1.	Certificate in Astrology (CIA)	Any Master's degree with a Diploma in Astrology or UG or PG in a the relevant subject by a recognized university
2.	Diploma in Astrology (DIA)	Master's Degree in any discipline with minimum 3 years of experience as Asst. Professor/Professors at undergraduate/Postgraduate level teaching the subject AND Certificate in Astrology /Diploma in Astrology or undergraduate or Postgraduate degree in the relevant subject from the recognized university approved by the UGC. OR Postgraduate or graduate in any discipline with Certificate/Diploma in Astrology or equivalent course from recognized institutions.

12. CONDITIONS FOR INSTITUTIONS

Infrastructure facilities:


- 12.1. Institutions applying for recognition as study centres must have adequate teaching rooms with modern infrastructural facilities.
- 12.2. Institutions willing to offer these courses have to apply for the recognition in the prescribed format.
- 12.3. Institutions shall bear the expenditure of inspection and shall pay the prescribed fees of the university.
- 12.4. A minimum of 5 years continuous instruction in the field is the eligibility to get the permanent recognition.
- 12.5. Institution recognized as "Study Centre" shall appoint eligible teachers as per rule.
- 12.6. Study centre shall be held responsible for instruction and other parts of the course.

13. DISPUTE JURISDICTION

- 13.1. Any dispute in this matter shall be resolved within the University. Vice-chancellor shall be the chair of the committee appointed for this purpose.
- 13.2. The jurisdiction of the dispute shall be Bangalore only.



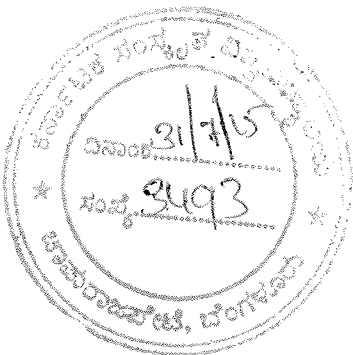

This Statute is framed under section 38, Sub section 9,10 of K.S.U. Act, 2010.

1. Preamble:

The Cadres and Recruitment Rules (C&R) framed by the expert committee and approved by the Syndicate and the Academic Council of the Karnataka Samskrit University were assented to by the Hon'ble Chancellor and His Excellency the Governor of Karnataka on 14.05.2012, communicated by the State Govt vide Order No. ED 213 URC 2011 and notified by the University. The Statute relating to the Cadres and Recruitment Rules has made provision for recruitment of the Research Assistants (Academics), but no provision has been made pertaining to the Job Description of their Duties and Responsibilities. Hence, this draft Statute has been framed with some modifications and amendments and submitted to the competent authorities for appropriate action.

2. Short Title and Commencement:

This Statute shall be called "**Statutes relating to the Job description of the duties, responsibilities of Research Assistants (Academic) of Karnataka Samskrit University**" and it shall come into force from the date of assent of the Hon'ble Chancellor and His Excellency the Governor of Karnataka.

3. Definitions:

- A) "**University**" means Karnataka Samskrit University.
- B) "**Act**" means Karnataka Samskrit University Act 2010.
- C) "**Authority**" means the Syndicate and the Academic Council constituted from time to time.
- D) "**Research Assistants**" – The nomenclature of Planning Assistants shall be altered as Research Assistants and the C & R Rules shall stand amended to that affect.

4. Placement:

These employees are appointed as Research Assistants shall be given placement under different faculties depending upon the needs and requirements of the respective disciplines.

5. **Recruitment and Qualifications:**

The norms and the criteria mentioned in the Cadre and Recruitment Rules relating to the Research Assistants shall be followed.

6. **Reservation:**

The State Government Order of Karnataka issued from time to time shall be followed. And also provisions under Article 371 (J) will be followed at the time of new Recruitment and promotions.

7. **Advertisement:** The vacancies related to the Research Assistants shall be advertised in one State level Kannada daily newspaper and similarly another advertisement shall be published in a National level English daily newspaper.

The Board to select the Research Assistants shall be constituted as follows :

10. **Duties and Responsibilities of the Research Assistants are mentioned below:**

The employee shall work under the Dean of the Faculty/Head of the Dept in which he is appointed or deputed.

- A. Assistance in preparing of Teaching materials/Curriculum like PPT etc.,
- B. Responsibilities in the Projects taken by the Dept/Faculty.
- C. Editing and proof correction work of the Texts/Manuscripts.
- D. Preparing the syllabus for the Faculty/Dept.
- E. Any work – Teaching/Research/Administration in the Dept/faculty assigned by the Dean/Head.
- F. Any examination/Academic related work.
- G. Any other official work assigned from time to time on deputation by the Vice Chancellor.
- H. In case of any other assignment, the consent of the concerned Dean must be taken by the Administration.
- I. Leave Rules: The Research Assistants shall be treated as Non-vocational Academic Staff. They are eligible for non-vocational leave rules, until they are promoted to the Cadre of Assistant Professor under Career Advancement Scheme.

11. **Career Advancement Scheme for Research Assistants:**

50 % of the posts in the Cadre of Assistant Professor shall be filled up by general competition and the remaining 50 % of the posts shall be filled by promotion among the Research Assistants. The Research Assistants must fulfill all the eligibility conditions prescribed in the Cadre of Assistant Professor but they also have put in five years experience in the Cadre of Research Assistants. They will be promoted to the Cadre of Assistant Professors subject to the seniority and merit. (5 Years annual performance report). A separate board shall be constituted for promotion from the Cadre of Research Assistants to the Cadre of Assistant Professors. A promotion board shall be constituted as mentioned below.

12. In the original Cadre & Recruitment rules, already assented to by the Hon'ble Chancellor and His Excellency the Governor of Karnataka, the posts have been designated as Planning Assistants and in this statute, they will be re-designated as Research Assistants, since these Assistants are working under various research projects which are related to Academic duties and responsibilities.
