OR OTHER ACADEMIC DISTINCTIONS (HONOURIS CAUSA) IN  
KARNATAKA SAMSKRITA VISHWAVIDYALAYA.**


(Framed Under Section 5(3), 22(8), 38(2) and 39 of The Karnataka Samskrita  
Vishwavidyalaya Act, 2009)

**1. Title and Commencement:**


- (i) These statutes shall be called 'Statutes Governing Conferment of Honorary Degree or other academic distinctions (Honouris Causa) in Karnataka Samskrita Vishwavidyalaya.
- (ii) These statutes shall come into effect from the date of assent of the Chancellor.

**2. Honorary Degrees or Other Academic Distinctions:-**

- 1. The Honorary degree or distinction may be conferred only in exceptional cases. Only such of the persons who have contributed substantially in the area of Prose, Poetry, Drama, Sculpture, Paintings, Fine arts, Medicines, Philosophy and other allied areas, conspicuous service rendered by them and advanced study and research in the fields like 1. Geeta based Management, 2. Yoga based Human Psychology, 3. Eco balance related Health related traditional knowledge, 4. Archeology, 5. Ancient Sciences, 6. Agama Shashtra, 7. Ayurveda Sciences, 8. Humanities, 9. Performing Arts, 10. Fine Arts and Communication, 11. Vedadhyayana and Vedabhashya Studies and any other Subjects that are related to Sanskrit or to the cause of education shall be identified as per the objectives of the University as mentioned in sec (4) of Karnataka Samskrita Vishwavidyalaya Act 2009, for the purpose of grant of such Honorary Degrees (Honouris Causa).

2. The University may confer not more than three honorary degrees or other academic distinctions per year, in the fields of development of Sanskrit.
  3. The honorary degrees or other academic distinctions shall be conferred at the annual convocation of the University.
  4. Honorary degrees or other academic distinctions shall be conferred only at the Annual Convocation and may be taken in person or in absentia.
  5. The presentation of persons at the convocation on whom Honorary degrees or other academic distinctions are to be conferred shall be made by the Vice-Chancellor.
  6. The Certificate for an Honorary Degree shall be signed by the Chancellor/ Pro-Chancellor and the Vice-Chancellor.
  7. The procedure outlined in the Statutes governing the Annual Convocation shall apply mutatis and mutandis in the case of conferment of Honorary Degrees also except that in the latter case the recipient of the Honorary Degree may be allowed to make a brief address after receiving the degree and be a member of the convocation.
3. **Eligibility Criteria for Conferment of Honorary degrees or other Academic Distinctions**

The following persons shall be considered eligible for conferment of honorary degrees or other academic distinctions, namely: -



1. Persons of distinguished merit who have made outstanding contributions in the sphere of their activities as evidenced by their individual standing and stature, eminence of their personality and impact of their contributions on the society.
2. Distinguished traditional scholars of national and international recognition/reputation who have put in highest quality research work accepted academia.
3. Persons who have significantly contributed either through research or through high quality social work to the cause of development and empowerment of women and disadvantaged section of the society.
4. **Procedure for Conferment of Honorary degrees or other Academic Distinctions.**


1. The University shall identify the candidates through the members of Academic council and Syndicate in respect of conferment of honorary degree or academic distinction in the fields as mentioned in section 2 (1) there in the fulfillment of eligibility conditions.
2. Not less than two thirds of the members of the Syndicate recommend that an honorary degree or other academic distinction be conferred on any person on the ground that he is in its opinion, by reason of eminent attainment and position, fit and proper to receive such degree or academic distinction, the Syndicate may recommend the same for the approval of the Chancellor for conferment of such degree on the person concerned.
3. The names before proposed must be properly considered and deliberated in the Syndicate.



4. After deliberation and consideration of such names in the Syndicate, the same shall be forwarded to the Scrutinizing Committee by the University.
5. The Chancellor may constitute an expert scrutiny committee consisting of three members. One among the members of the committee is the nominee of the University nominated from amongst the former Vice Chancellors, retired Secretaries of Govt. of Karnataka, or Govt. of India.
6. The University may nominate its nominee to the Scrutinizing Committee well in advance.
7. The recommendations of the University for conferring Honorary Degree must be forwarded to the Scrutinizing Committee at least 45 days in advance to the date of Convocation.
8. The number of names proposed by the Scrutiny Committee to confer honorary degrees should not exceed more than three in a year,
9. The names proposed/recommended by the Syndicate of the University should be kept confidential and under no circumstances be disclosed to the recipient or the press till the approval of the Chancellor is communicated.
10. An honorary degree or academic distinction shall not be considered as an academic qualification.



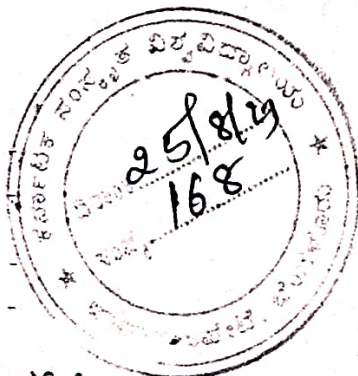
